The time has also come to pay our dues for 2017. It is greatly appreciated if you renew your membership by check to help avoid confusion. Please send your renewal to Linda Wojnar. She will update our roster and forward the funds to the Treasurer.

A Safety Reminder; It has been reported to me that some members have been taxiing back from the pilot line. Last summer I had talked with Mark Radcliff about safety rules and recommendations. Mark was very adamant that pilots shut down their aircraft (gas or electric) and carry or drag it back to the pits. If there is a control failure, the aircraft is pointed towards people and automobiles. It is ok to taxi toward the runway because you are going away from people and automobiles. If you are unable to retrieve it yourself, ask for help.

#### **NOVEMBER - President's Corner Continued**

Some of the most important rules are:

- 1. All pilots are to stand an equal distance back from the safety line. The first pilot in the air sets this distance.
- 2. No flying of any kind from behind the safety line. This includes hand launching aircraft.

This past August I made some changes to the field layout in accordance with my talk with Mark Radcliff. When Mark Radcliff and Tony Stillman attended our meeting on August 26, they said that they liked our field layout. They also said that it is up to our members to decide what the rules are.


#### Currently the field layout is,

- 1. The pilot line is behind the high grass barrier. Pilots are permitted to stand anywhere from behind the high grass to 35 feet back (the old pilot stations). Pilots flying at the same time must all stand an equal distance back from the pilot line. It is recommended that pilots stand close enough to each other to communicate.
- 2. The Safety Line is 25 feet out on the runway from the pilot line. Between the Safety Line and the Pilot Line is the Taxiway. The purpose of this part of our layout is to comply with part B item 6 of the AMA National Safety Code. (With the exception of events flown under official AMA Competition Regulations, Excluding takeoffs and landing, no powered model may be flown outdoors closer than 25 feet to any individual, except for the pilot and pilot's helper(s) located at the flight line.)

No field layout is perfect. There will always be some detail that can be pointed to and questioned. This is a good layout, we will all be safer if we abide by it.

The meeting of the MVRC Club was called to order at 7:37 PM at the Rostraver Municipal Building with the Pledge of Allegiance. Minutes from the October 7 Meeting were read and approved on a motion by Bob Haden and seconded by Lew Marascalco. All members approved the minutes as read.

Al thanked Ron Doctorick for his work in acquiring a PPG donation of \$500 for March for Parks. Al is talking with Jeff Sumey regarding California University's UAV Certification. Jeff Sumey is really on top of this. If you have any questions, see Jeff.

#### **Executive Committee:**

• Rick Altomari reported the main thing is receiving an invitation to attend a meeting on 11/15 to meet with 2/3 of the county commissioners to tell them all we do in the club and in the community. On December 1 the county enters their budget. We want to put our best foot forward. We want the pavilion to stay in the budget proposal.

## Safety Officer Report – Al Kozusko

Although the "Academy of Model Aeronautics National Model Aircraft Safety Code" gives us a detail list of criteria to fly safely I thought it would be good to high lite some of the following items:

- 1. All pilots shall avoid flying directly over unprotected people, vessels, vehicles or structures and shall avoid endangerment of life and property of others.
- 2. At all flyings sites a safety line(s) must be established in front of which all flying takes place.
- 3. No powered model may be flown outdoors closer than 25 feet to any individual, except for the pilot's helper(s) located at the flightline.

MVRC airfield safety line is 15 feet in front of the grass barrier. The pilot line is 25 feet behind the safety line. All pilots flying should stand behind the grass barriers.







# Show 'N Tell.....LED LIGHTS (I found at Tractor Supply and I understand at Harbor Freight.) George Wilson



The light is a dual LED light. The lights are on par with the Moonstones that are popular in the club, like those used by Lew Marascalco and Ron Doctorick. The main attractive feature is cost. Moonstones run about \$5 each. The dual light from TS is \$5.00. In addition it features a reflector, lens cover and heat sink/PC board. Heat sinking is a critical feature of any LED lamp. With the TS lights it is included. Also, if you wish to "bash" the light for RC applications (which I am doing) you can take the powerful magnet out of the back. It could be used for things like hatch covers. At the next meeting I intend to show how to modify the light so that it will fit in an airplane or on a quad.

### WINTER PROJECT LOCKHEED LIGHTNING RC



Attached are beginning photos of my winter project which I have begun approximately 3 weeks ago. In fact, it may take two winters! The kit was in Don Weisensee's archives. The ROYAL kit (74 inch wingspan) is no longer in production, so there is little recourse for information. Instructions are vague (made in Japan). Planning the assembly is very demanding. If there are identical parts (i.e. there are many and quite a few requiring four of the same), only one is identified with a number. The other identical parts must be found and labeled. With 200-300 parts, this took some time.

The plans are quite large and do give some illustrative information. I wouldn't recommend this project for a beginner. Of course we seem to be losing "home builders" with the infusion of ARFs. In fact, this may be my last "hurrah". My plans are to use two four-cycle 60 glow motors.

Don't get me wrong. I, for 50 years, have enjoyed, and continue to enjoy, the building aspect of the hobby.














#### Show 'N Tell.....SUBTERRANEAN DRONE

For nearly a year now, I have been working with the Electrical and Computer Engineering Department at West Virginia University on a research project involving the development of a drone that can be deployed in a mine environment and tasked with various objectives such video recon and identification of "hot spots" which potentially indicate fire locations. I was originally brought into the project to be the test pilot and consultant but then quickly moved into hardware/software development areas as well. Our recent work involved developing a platform that could be sent down into an underground mine via an 8" borehole like the one you may remember was drilled in the Quecreek mine incident in 2002 near Somerset, PA. The concept centered around the idea of using a quadrotor platform with moveable arms that could be retracted for the trek down the borehole then be deployed once through the hole and into the open mine. We started with a DJI Matrice 100 but ended up casting aside everything but the arm/motor/prop assemblies and developed a replacement main body unit. As shown in these photos, the arms are linked via CF plates and robotic gear drives driven by a single Hitec 7954HV high torque servo to retract the arms into transit position and then deploy them for flight operation. For demonstration purposes, I configured this prototype to fly on a SP F3 flight control board running Cleanflight, which readily yielded a stable, reliable, easily controlled UAS. The "headlight" is one of the relatively new 10W "COB" type LED modules, which is currently run at 2W using the really cool 2A DC-DC buck converter that Lew Marascalco demonstrated in a previous club meeting. Even at only 2W, it lit up the club meeting room after the house lights were turned off. There are many other interesting parts of this project such as surfaceunderground communication links, wall/ceiling avoidance, in-flight battery replacement, and use of underground RF repeaters. However, this is an on-going with much remaining work to be accomplished. Anyone know of any possible funding sources?

- ★ <u>Time and Personnel Permitting</u> When possible and available, ask one club member to wait at the Rt. 51S turn off area (until help arrives) to direct emergency vehicles (ambulance, fire truck, etc.) to Timms Lane.
- ★ Depending upon the emergency, car 4-way flashers may be of assistance to narrow down exact location of the emergency
- **★ Notify a Safety Officer Mike Eiben or Bob Haden.**
- ★ For any questions or suggestions, please contact Mike or Bob.
